Option 1- Core Program

Option 2- Home School/ Alternative School Cohort (For families that are currently homeschooling or in an independent study program)

- 3 virtual forums for families to discuss and troubleshoot facilitated by professionals in the field on accommodations, modifications, and specific topics related to homeschooling/independent studies - Dates TBD (dependent upon enrollment)

All participating educators will have the opportunity to participate in the Full Educator Course Cohort (NOT mandatory- open to the 25 participants for a year long commitment of completing 25 hours of participation)-- All participants to complete the program will earn a stipend!
