



Stepping Up is a uniquely developed program that includes a Parent Education and Child Learning opportunity and is specifically designed to support families of young children with Down syndrome as they transition from Early Intervention Services through the early elementary grades. Kristin Enriquez M.A., and a parent of a child with Down syndrome, developed the program and presents the parent sessions (Early Intervention, Preschool, Kindergarten, and Early Elementary). Through Kristin's vast experience, parents will become prepared for their child's IEPs, learn strategies to use at home, and share those same strategies with their child's teaching team for better transitions.

### What Makes Stepping Up Different:

- Combination of parent education and child learning opportunities
- Two methods of parent involvement
  - Parent education session (virtual)
  - Second Saturday workshops (in-person)
- Featuring 10 topics on Down syndrome and Important Issues Related to Special Education Systems specifically focused on where your child is in school
- Systematic support from transition of early intervention services through early elementary school years
- Content is applied to current issues in educational systems
- Developed by a parent of a child with Down syndrome who has been an educator in public school systems and continues to support students, families, and educators
- 10 Student Sessions meet monthly in age-appropriate groupings (EI, Pre-K, Kinder, Early Elementary) while Parents are at their Workshop (Second Saturday)

### Program Goals:

- Feel more confident collaborating with your child's IEP team
- Develop a clear understanding of how your child learns
- Learn new strategies to increase participation and learning at home and school
- Opportunity to learn information to bring to your child's educational support team

### Parent + Child - \$600 (\$550 if paid in full) which includes:

- 1.5 hr Parent lecture with Kristin (virtual)
- 1 hr Parent workshop (in-person on Second Saturdays)
- Child participation (in the student classroom on Second Saturdays - with classroom teachers and therapists)

### Parent Lecture with Kristin - \$400 which includes:

- 1.5 hr Parent lecture with Kristin ONLY (virtual)

## INFORMATION ON VENDORIZATION OF PROGRAMS

Club 21 programs are vendored by the Frank D Lanterman Regional Center. If you have a different Regional Center, **you can still ask** for this program to be vendored.

You must ask your service coordinator to **contact Yolie Marquez at [YMarquez@lanterman.org](mailto:YMarquez@lanterman.org)** and request a “**Courtesy Vendor Number**” for the program you are wanting to attend. If you talk to them, remember to ALWAYS follow up with an email (to keep a paper trail). Service Coordinators are inundated with requests. We suggest that you call/email and follow up with them every several days.

### **If you write an email, You might write something similar to this below**

*“Dear Service Coordinator, It is important for me to get the most current information on Down syndrome that will help me in supporting my child’s growth on becoming an independent part of society. Club 21 Learning and Resource Center has a specific program that will support me and my child. The program is vendored through Lanterman RC but they will issue a Courtesy vendorization number for other families outside their area.
